STUDENT REGISTRATION IN FIRST PROFESSIONAL MBBS EXAMINATION OF 2023-24 ADMISSION BATCH.

It is for the information of all Principal of affiliated Colleges offering, MBBS Course during the academic session 2023-24 that the 1st Professional (Regular) Examination: 2023 is likely to commence from 2nd week of August, 2024.

In view, all are requested to register their eligible students of the Course to appear in the 1st Professional MBBS (Regular) Examination: 2023-24 within the dates and fees as under;



1	MBBS	2500	12.07.2024 to 18.07.2024	19.07.2024 To 20.07.2024	Colleges shall retain 15% of the Examination fee towards Centre Charges.

In addition, all Principal of the College (s) are requested to duly fill in the prescribed Application Form (s) by the eligible students within the prescribed date, and submit to the University along with "Statement of Students (Registered & Not Registered)" and prescribed fees deducting 15% at College towards Centre Charges.

The College shall prepare the Bank Drafts / Bankers Cheque in respect of all students who filled in their forms without fine on the following day and similarly the students filled their form with fine. All Bank drafts/Banker's Cheques in support of deposit of fees shall be drawn in favour of "**Registrar, Odisha University of Health Sciences**", payable at Bhubaneswar. No College shall collect Demand Drafts / Bankers Cheque from the students in favour of the University.

Besides, all verifying officer to verify the application forms minutely as per regulations of the University and put his / her signature, seal and date on the bottom of each form as specified. Both the Principal and Verifying Officer will be held responsible for any irregularities made therein and also be liable for any lapses if found later on.

No extension of date, and lateral permission to student (s) for registration to 1st Professional MBBS (Regular) Examination: 2023 shall be entertained.




