Sub: Mandatory Installation of Audio-Video CCTV Cameras, Biometric Attendance, in Affiliated Nursing Colleges/Institutions under OUHS

Madam/Sir,

I am directed to invite reference on the above subject and to state that as per the proceedings of Disciplinary committee held on 21.07.2025, it is decided that all affiliated nursing colleges under OUHS are instructed to install the following infrastructure on or before 2nd September 2025:

- 1. Audio-Video Cameras in all the classrooms and Examination Halls
- 2. Biometric Attendance Machines for both faculties and students

Failure to install the above-mentioned infrastructure by the specified deadline may result in your institution not being considered as an examination centre.

As per the guidelines of the Indian Nursing Council (INC) and Odisha University of Health Sciences (OUHS), the following attendance criteria must be strictly followed:

- M.Sc. Nursing Students:
 - Minimum 75% attendance in theory
 - 100% attendance in practical's
- Post Basic B.Sc. Nursing Students:
 - Minimum 80% attendance in theory
 - 100% attendance in practical's
 - Attendance must be maintained separately for each subject

Note: - Students not meeting the above criteria for attendance will not be permitted to appear for the university examinations.

All concerned institutions are requested to ensure strict compliance.
