## NOTICE

This is with reference to Notice No. 2065-E dated 16.04.2026 regarding the submission of the list of Internal Examiners for PB B.Sc. Nursing and M.Sc. Nursing Practical Examination for Regular (2024–25) and Back (2023–24), along with relevant experience certificates, joining letters, and qualification certificates.

The University hereby informs that, as per **INC Guidelines under Clause 5 (22) on page no. 243 of Gazette Notification No. 275 dated 05.07.2021**, the eligibility criteria for examiners are as follows:

### **An examiner for Theory and Practical/OSCE examination must be**

- An Assistant Professor or above in a College of Nursing, possessing M.Sc. (Nursing) in the concerned subject with a minimum of 3 years of teaching experience.
- For the Nursing Foundations course, faculty having M.Sc. (Nursing) with any specialty shall be considered eligible.
- In accordance with the above clause, it is further clarified that Tutor/Lecturer or above in a Government College of Nursing, fulfilling all other prescribed criteria—i.e., possessing M.Sc. (Nursing) in the concerned subject and a minimum of 3 years of teaching experience in their specialty—shall also be considered eligible as examiners for both Theory and Practical examinations.
- **School-level experience (ANM/GNM) shall not be considered** for appointment as Examiner or Evaluator for B.Sc., PB B.Sc., and M.Sc. Nursing examinations. Only collegiate-level teaching experience will be counted.

**The University shall strictly adhere to these INC guidelines for all Nursing examinations. Therefore, if any college does not have eligible faculty on this basis or fails to submit the required documents within the prescribed time, the University will depute Internal Examiners to such colleges. This rule shall be applicable to all upcoming Nursing examinations.**
